The KKH Pflegekasse is one of Germany's statutory care insurance funds (*gesetzliche Pflegekasse*). It supports insured individuals who have been assigned a recognised care level — **Pflegegrad 1 through 5** — covering a wide range of services and financial assistance designed to promote independent, home-based living.

Who It Serves

Insured individuals in Germany with a formally recognised care level (Pflegegrad 1–5).

Core Focus

Maintaining and improving home-based care arrangements to preserve dignity and independence.

Relocation Support

One of several benefits available — financial reimbursement for moves that improve living and care conditions.

The Legal Foundation: § 40 Abs. 4 SGB XI

"Measures to improve the individual living environment of persons requiring care" — Social Code Book XI, § 40 Abs. 4

The relocation subsidy is grounded in German social law. **§ 40 Abs. 4 of the Social Code Book XI (SGB XI)** mandates that the care fund may provide financial assistance for measures — including relocation — that meaningfully improve the living situation of a care recipient.

Scope of the Law

Covers environmental adaptations and relocations that enable or significantly improve the delivery of home-based care.

Who Benefits

Individuals with Pflegegrad 1–5 whose current living environment is unsuitable for their care needs.

Goal of the Legislation

To preserve autonomy, support home care, and reduce unnecessary transitions to institutional settings.

Financial Assistance: How Much Can You Receive?

The KKH Pflegekasse relocation subsidy offers meaningful financial relief to cover the costs of a necessary move. The amounts are set by law and apply per care recipient.

€4,180

Per Person

Maximum reimbursement available to a single care recipient for eligible relocation costs.

€16,720

Shared Household

Total maximum available for up to four care recipients living and moving together — e.g. a senior living group.

People Maximum

Up to four individuals in a shared household can each access subsidy support within the combined ceiling.

What the Subsidy Is Designed to Cover

These funds are specifically intended to reduce the financial burden of a relocation that improves care or living conditions — not simply any move. Understanding what is included helps you plan effectively and submit a complete application.

→ Professional Moving Costs

Charges from a qualified moving company for packing, transportation, and delivery to the new home.

→ Housing Preparation

Essential modifications or installations required to make the new home suitable for the care recipient's needs.

→ Administrative and Documentation Costs

Costs directly associated with the application and preparation process may be considered as part of the overall submission.

Eligibility Criteria for Relocation Subsidies

Not every move qualifies for KKH Pflegekasse funding. Two core conditions must be met before an application can be considered. Understanding these criteria early saves time and prevents disappointment.

1. The Move Must Be Necessary

The relocation must be essential to:

- Enable home care that cannot otherwise be provided
- Significantly improve the delivery of existing home care
- Restore a meaningful degree of self-sufficiency in daily life

2. Pre-Approval Is Mandatory

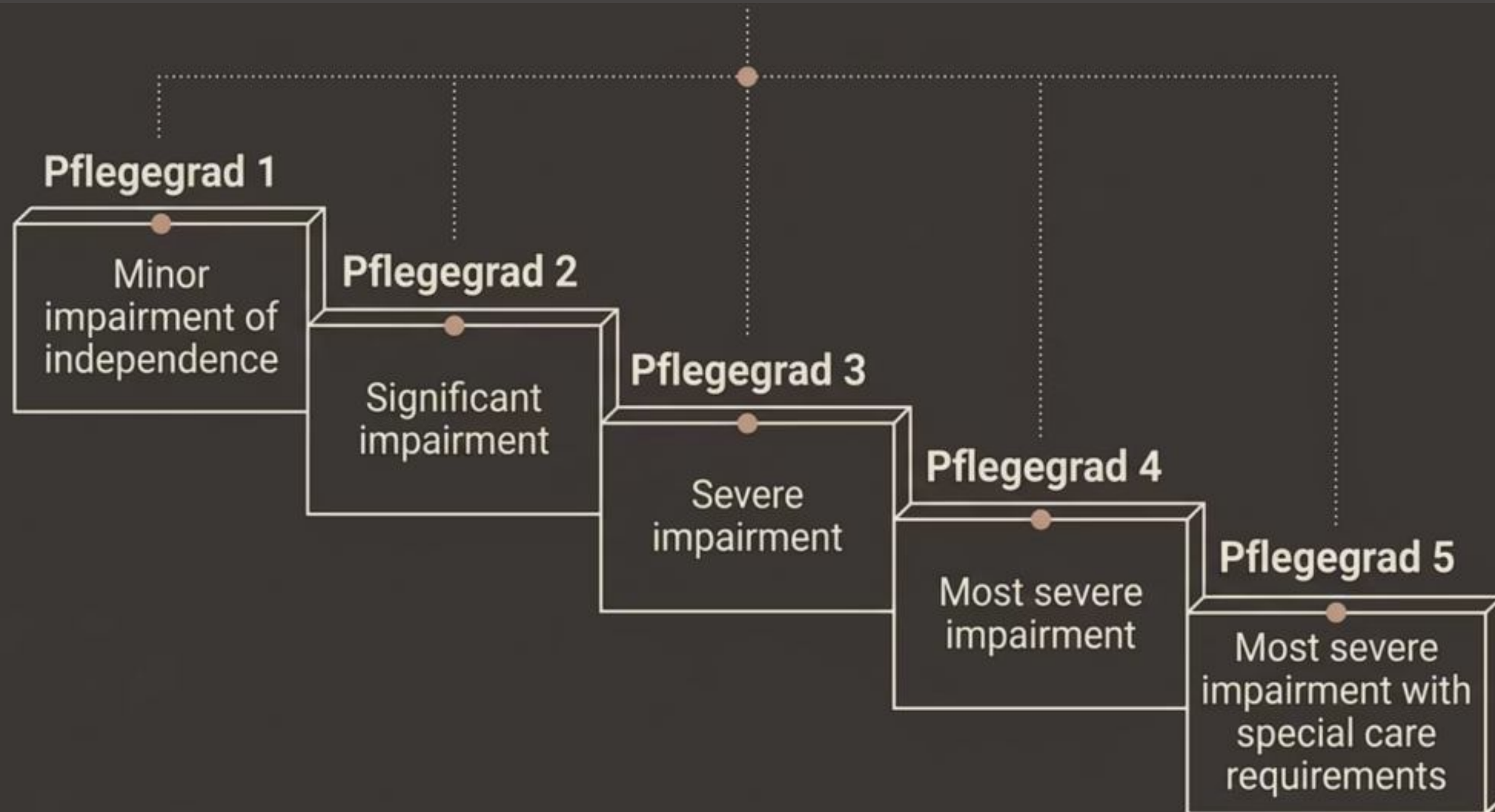
The application **must be submitted and approved before the move takes place**. This means:

- Submitting all required documentation in advance
- Providing a detailed cost estimate from a professional mover
- Waiting for written confirmation from KKH Pflegekasse

Who Qualifies? Care Levels Explained

In Germany, eligibility for care fund benefits — including relocation subsidies — depends on having a formally assigned **Pflegegrad** (care level). These levels are assessed by the Medical Service of the health insurance funds (MDK).



All levels 1-5 are eligible for relocation subsidies.

All five levels — from Pflegegrad 1 to Pflegegrad 5 — are eligible for the relocation subsidy, provided the other criteria are met.

IMPORTANT LIMITATION

What the Subsidy Does *Not* Cover

It is important to understand the boundaries of the KKH Pflegekasse relocation subsidy. The primary purpose of this funding is to support **home-based care arrangements** — not to fund admission into institutional settings.

- ❑ **Key Exclusion:** Relocations to **stationary care facilities** (full-time nursing homes or residential care homes) are generally **not covered** by this subsidy. The fund's focus is on preserving and improving home care environments, not on funding permanent institutional placements.

Moves to **assisted living facilities** or **barrier-free shared housing** where home care continues to be provided may still qualify. If you are unsure whether your planned move is eligible, consult KKH Pflegekasse or Butler Umzüge GmbH before proceeding.

Types of Housing That Qualify

The subsidy supports transitions to a range of housing options — as long as the new environment improves the care situation and promotes independence.



Barrier-Free Apartments

Homes designed or adapted to accommodate wheelchairs, walkers, and reduced mobility — step-free access, grab rails, and accessible wet room



Assisted Living Facilities

Residential settings where home care services are delivered on-site, combining independence with professional support.



Senior Shared Households

Shared living arrangements for multiple seniors requiring care, enabling social connection and cost-sharing while retaining access to home-based care services.

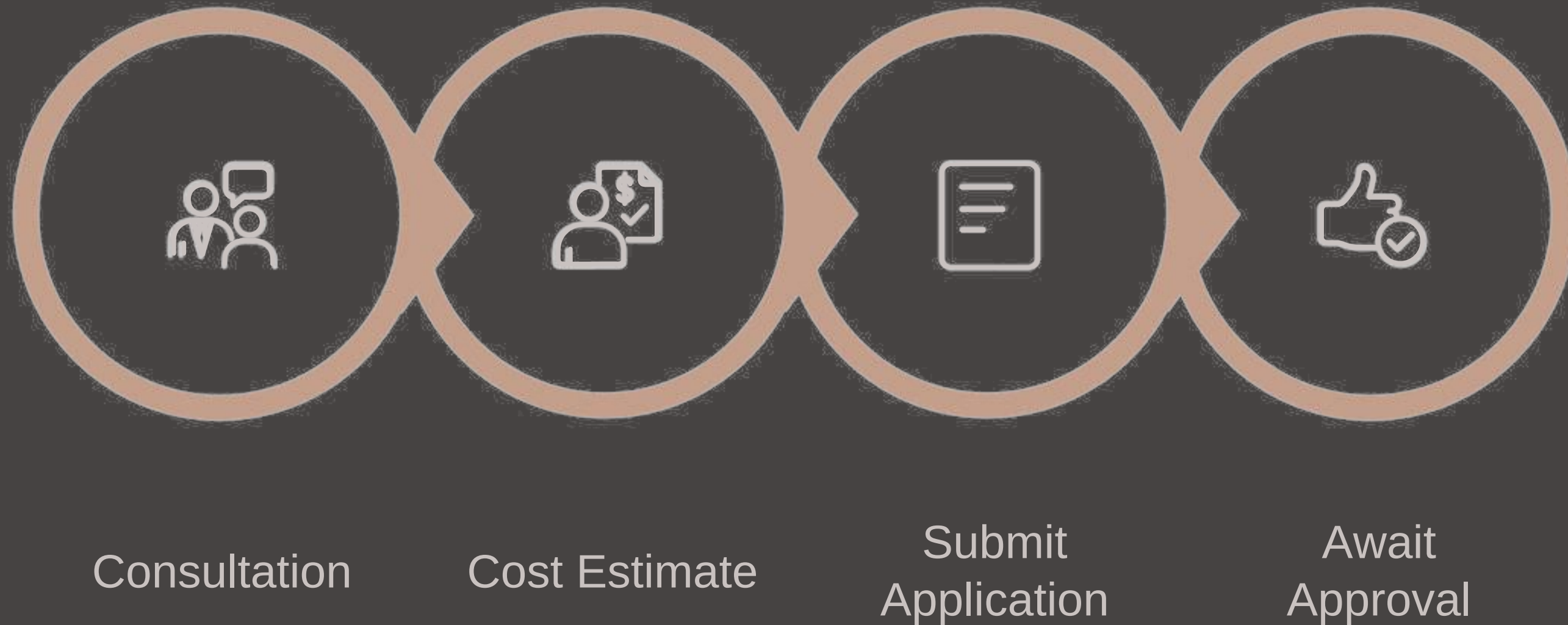

The Application Process at a Glance



Following this process carefully — and in order — is essential. Skipping ahead to the move before receiving written approval will result in the loss of funding. Butler Umzüge GmbH can support you at every stage.



Step 1: Initial Consultation

The first step is to assess whether your planned move meets the eligibility requirements under **§ 40 Abs. 4 SGB XI**. This consultation helps identify the right path forward before any costs are incurred.

Assess Your Care Level

Confirm your Pflegegrad (1–5) with your KKH Pflegekasse documentation. This is the foundation of eligibility.

Define the Reason for Moving

Clearly articulate why the current home is unsuitable and how the new home will improve care or independence.

Step 2: Obtain a Professional Cost Estimate

Before submitting your application to KKH Pflegekasse, you must obtain a **detailed, itemised cost estimate** from a professional moving company. This document is a required part of the application.

- ❑ **Important:** The cost estimate must come from a **professional, qualified moving company**. Butler Umzüge GmbH provides these estimates in the format required by KKH Pflegekasse, ensuring your application is complete and compliant.

Itemised list of all moving services, labour costs, transport, packing materials, and any housing adaptations planned.

Step 3: Submit the Application — Before You Move

Critical Reminder

Do not move before receiving written approval. Applications submitted after the relocation has taken place will not be considered. Pre-approval is a firm legal requirement under SGB XI.

What to Submit

- Completed application form to KKH Pflegekasse
- Proof of Pflegegrad (care level certificate)
- Medical records or care assessment documentation
- Detailed cost estimate from Butler Umzüge GmbH
- Written explanation of why the move is necessary

Step 4: Await Approval, Then Move

Once the application has been submitted, KKH Pflegekasse will review the documentation and make a determination. Processing times may vary — consult your case adviser for current timelines.

Reimbursement Process

Pre-Approval Is Non-Negotiable

No approval = no funding.

This is the single most important rule of the entire process. **Funding will not be granted retroactively** for moves that have already taken place. There are no exceptions to this requirement under § 40 Abs. 4 SGB XI.

Why the Law Requires Pre-Approval

Pre-approval allows KKH Pflegekasse to verify eligibility, assess the necessity of the move, and confirm that the new living environment meets the required care standards — before funds are committed.

What Happens Without It

If you move first and apply later, your application will be rejected regardless of your care level or how appropriate the new home is. The subsidy cannot be claimed after the fact.



Focus on Home-Based Care

The KKH Pflegekasse relocation subsidy exists with one primary aim: to **maintain, restore, or improve home-based care arrangements**. Understanding this focus helps applicants frame their move correctly and successfully.

Promote Independent Living

The new home should enable the care recipient to manage more daily activities independently — or with less intensive support — than was possible before.

Each individual must hold a recognised care level (Pflegegrad 1–5) and each must submit their own application. The combined maximum applies only when all individuals are moving together into a shared home-care arrangement.

Can Caregivers Also Apply?

Yes — In Some Circumstances

Caregivers — whether professional or family members — may be eligible for relocation support if the move is directly tied to improving the home care arrangement for a person with a recognised Pflegegrad.

What This Means in Practice

If a caregiver relocates alongside or near the care recipient to better provide support, this may be considered as part of the overall improvement to the care environment. Each case is assessed individually by KKH Pflegekasse.

- Eligibility is tied to the care recipient's needs
- The primary basis must always be home care improvement
- Consult KKH Pflegekasse to assess your specific situation

Subsidies Within Germany and Across Europe

The KKH Pflegekasse relocation subsidy applies to moves **within Germany** and to **other European destinations**, provided the relocation demonstrably improves the care situation or living conditions of the individual. Butler Umzüge GmbH operates across the full breadth of this geography.

Within Germany

Relocations between cities, regions, or care zones — all covered provided eligibility criteria are met.

Across Europe

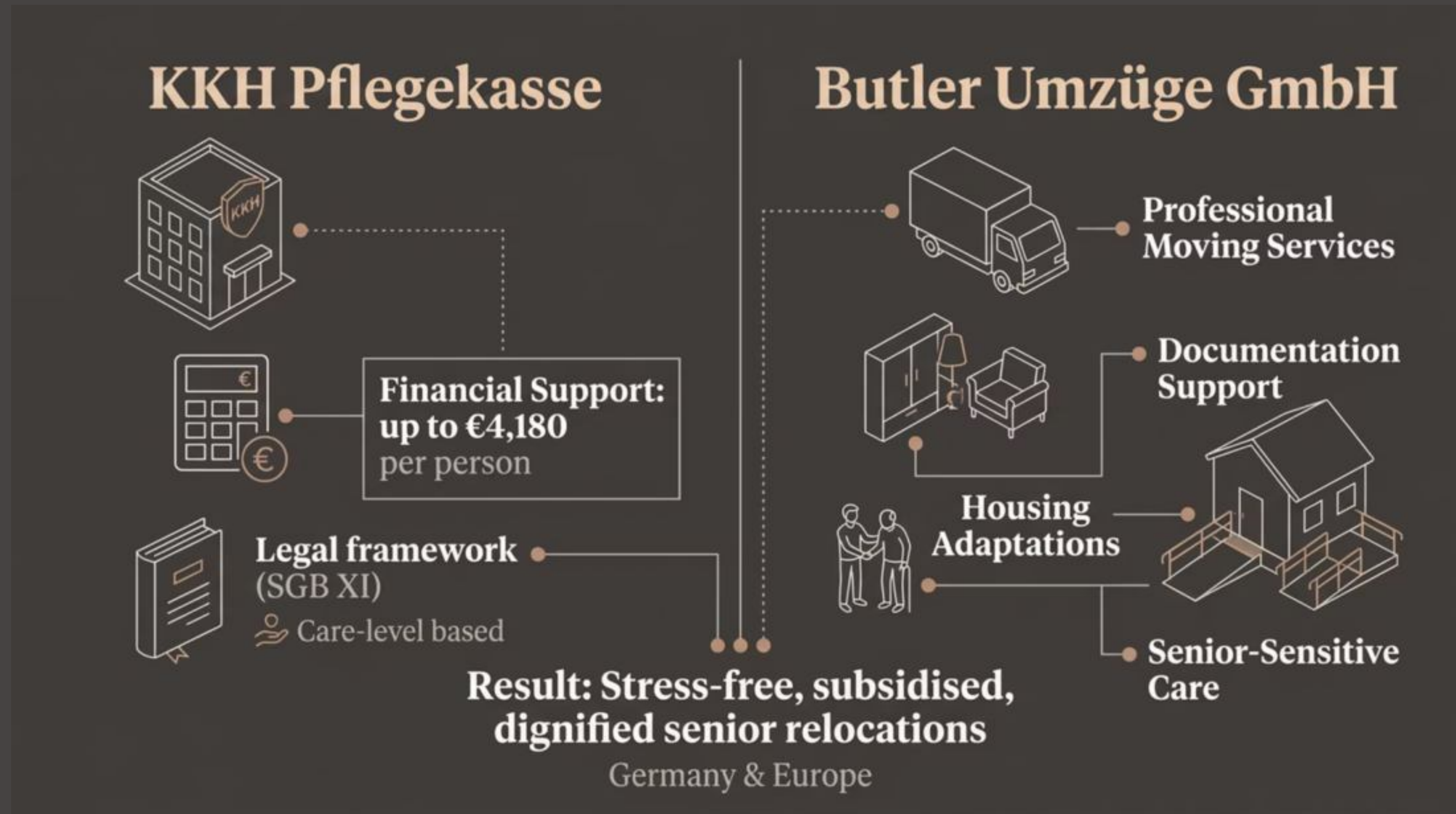

What is Pflegegrad?

Pflegegrad (care level) is a formal classification of care needs in Germany, ranging from 1 (minor impairment) to 5 (most severe, with special requirements). All five levels are eligible for relocation subsidies.

2

Can I apply after the move?

No. Pre-approval from KKH Pflegekasse is absolutely mandatory. Applications submitted after a move has taken place will not be considered — there are no retroactive payments.

3

Does the subsidy cover assisted living?

Yes — moves to assisted living facilities where home care continues can qualify. However, moves to stationary full-time nursing homes generally do not.

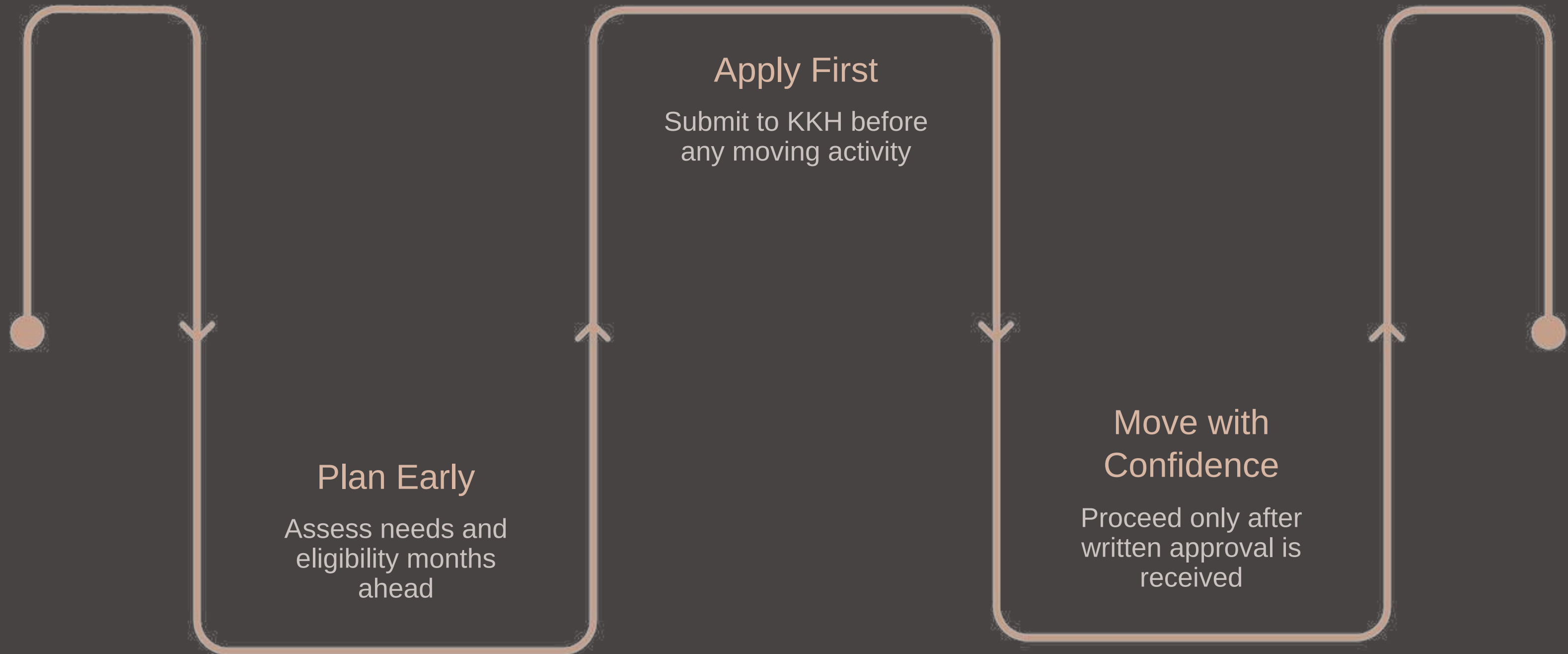

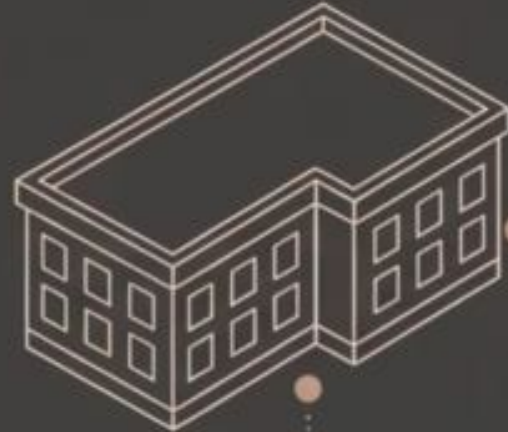
